Wellbeing of staff and customers

Exclude staff and customers who are unwell from the premises.

Staff and customers who mention are unwell will be advised they are unable to enter the premises.

Provide staff with information and training on COVID-19, including COVID-19 vaccination, when to get tested, physical distancing, wearing masks and cleaning. Train staff in the process of how to collect and store contact details of patrons.

Staff meeting and training held as well as additional resources emailed through to staff. Posters and signage relating to COVID-19 on display on restaurant entry and staff notice board.

Display conditions of entry including requirements to stay away if unwell, COVID-19 vaccination and record keeping.

Relevant COVID-19 conditions of entry displayed upon restaurant entry.

Take reasonable steps to ensure all people aged 16 and over on the premises are fully vaccinated or have a medical exemption (including staff, customers and contractors). For example, ensure posters outlining vaccination requirements are clearly visible, train staff on ways to check proof of COVID-19 vaccination status, remind customers of vaccination requirements in marketing materials. Note: Staff outside of Greater Sydney who have received one dose of a COVID-19 vaccine are permitted to work until 1 November 2021 when they need to be fully vaccinated.

Posters clearly visible for customers upon restaurant entry. Staff training and meeting held discussing vaccination requirements. Dedicated staff member will be stationed upon restaurant entry to ensure vaccination status abides by current public health orders.

People aged under 16 who are not fully vaccinated must be accompanied by a fully vaccinated member of their household.

Note: This does not apply to a person aged under 16 who is on the premises to carry out work.

Ensure children under the age of 16 are with a fully vaccinated household member.

Physical distancing

Capacity must not exceed one person per 4 square metres of space in indoor areas of the premises and one person per 2 square metres of space in outdoor areas of the premises.

Bookings must not exceed 20 customers (except for weddings and funerals, and gatherings after these events).

Note: This does not include a vessel used for commercial tours for scuba diving, snorkelling or marine animal watching if there are less than 50 persons on the vessel.

Capacity limits in place in all aspects of dining with display notices upon all sections of the restaurant.

Ensure 1.5m physical distancing where possible, including:

- **at points of mixing or queuing**
- **between seated groups**
- **between staff.**

Avoid congestion of people in specific areas where possible.

Have strategies in place to manage gatherings that may occur outside the premises and in any designated smoking areas.

Patrons can only consume alcohol when seated in indoor areas.

Ensure all customers are seated when inside the restaurant and no singing to take place.

Ventilation

All air conditioning units have been maintained and monthly maintenance scheduled.

Use outdoor settings wherever possible.

Outdoor settings to be suggested to customers as preferred option.

In indoor areas, increase natural ventilation by opening windows and doors where possible.

Windows and doors to be opened inside restaurant, weather permitting.

In indoor areas, increase mechanical ventilation where possible by optimising air conditioning or other system settings (such as by maximising the intake of outside air and reducing or avoiding recirculation of air).

Air conditioning systems to be in place to ensure ventilation.

Ensure mechanical ventilation systems are regularly maintained to optimise performance (for example through regular filter cleaning or filter changes).

Consider consulting relevant experts such as building owners or facility managers, ventilation engineers and industrial or occupational hygienists to optimise indoor ventilation.

Hygiene and cleaning

Face masks must be worn by staff and customers in indoor areas, and by public facing staff in outdoor areas, unless exempt.

Face masks to be worn by all staff and customers within and outside of the restaurant.

Adopt good hand hygiene practices. Have hand sanitiser at key points around the venue.

Hand sanitiser positioned through all key points of the restaurant and regularly filled.

Ensure bathrooms are well stocked with hand soap and paper towels or hand dryers.

Bathrooms checks to be completed and cleaned throughout service and at the end of service.

Clean frequently used indoor hard surface areas (including children's play areas) at least daily with detergent/disinfectant.

Clean frequently touched areas and surfaces several times per day, and clean tables, chairs and any table settings between each customer.

All indoor and outdoor services will be cleaned twice a day with disinfectant.

Record keeping

Use the NSW Government QR code system to collect an electronic record of the name, contact number and entry time for all staff, customers and contractors.

QR code check in system signage displayed at restaurant entry.

Processes must be in place to ensure that people provide the required contact information, such as by checking phones for the green tick to confirm they have checked in (keeping 1.5m physical distance between staff and patrons). QR codes should be clearly visible and accessible including at entrances to the premises.

Dedicated staff member at restaurant entry to ensure customers are using QR code check in process.

If a person is unable to provide contact details, for example due to age or language barriers, another person may provide contact details on their behalf. If it is not possible for check-in to occur, keep a record of the name, contact number and entry time for all staff, customers and contractors for a period of at least 28 days. These records must be provided in an electronic format such as a spreadsheet as soon as

possible, but within 4 hours, upon request from an authorised officer.

Dedicated spreadsheet in place to keep details of customers who are unable to QR code check in.

Other types of venues or facilities within the premises must complete COVID-19 Safety Plans where applicable. If contact details are captured electronically upon entry to the main premises on the relevant day, additional collection of contact details via electronic methods may not be required if there is no other public access to the sub-premises. However, additional contact details and time of entry must be captured where these sub-premises are gyms, entertainment facilities, hospitality venues, nightclubs and retail premises.
